## **Autumn Apple Chicken**

Cost: \$2.01/serving Prep Time: 20 min. Cook Time: 3-1/2 hours Yields: 4 servings



I'd just been apple picking and wanted to bake something new with the bounty. I decided on apple chicken by throwing them in the slow cooker with some barbecue sauce. The dish fills my whole house with the most delicious smell. —Caitlyn Hauser

### **Ingredients:**

- 1 tablespoon canola oil
- 4 bone-in chicken thighs (about 1-1/2 pounds), skin removed
- 1/4 teaspoon salt
- 1/4 teaspoon pepper
- 2 medium Fuji or Gala apples, coarsely chopped
- 1 medium onion, chopped
- 1 garlic clove, minced
- 1/3 cup barbecue sauce
- 1/4 cup apple cider or juice
- 1 tablespoon honey

- **1.** In a large skillet, heat oil over medium heat. Brown chicken thighs on both sides; sprinkle with salt and pepper. Transfer to a 3-gt. slow cooker; top with apples.
- **2.** Add onion to same skillet; cook and stir over medium heat 2-3 minutes or until tender. Add garlic; cook 1 minute longer. Stir in barbecue sauce, apple cider and honey; increase heat to medium-high. Cook 1 minute, stirring to loosen browned bits from pan. Pour over chicken and apples. Cook, covered, on low 3-1/2 to 4-1/2 hours or until chicken is tender.

**Freeze option:** Freeze cooled chicken mixture in freezer containers. To use, partially thaw in refrigerator overnight. Heat through in a covered saucepan, stirring occasionally.


#### **Emily Bravard**


